The Court is seized with three notices of case management with respect to file no. 500-11-052942-170 (cote 23), 500-17-099716-170 (cote 20) and 500-17-102553-180 (cote 6), which are joined for hearing with court file no. 500-17-098780-177 and court file no. 500-11-054154-188.

After discussion with counsel to the parties, it appears clearly that the parties agree to proceeding with an orderly liquidation of the Estate of the Late Rani Khanna and of the two corporations included in the said estate, namely 9143-5537 Québec inc. and 92906 Canada inc. This way of proceeding will avoid unnecessary court fighting to come to the same conclusion.


The undersigned has accepted to remain seized of these five court files in order to supervise the above-mentioned orderly liquidation.

At the Court's request, the parties have signed an agreement proposing Mr. Raymond Massi of Richter Advisory Group Inc. to act as liquidator and they remit to the Court said agreement and the Court hereby **RATIFIES** the said agreement and **ORDERS** the parties to abide by its terms.

The Court reiterates its message that the liquidation proceeds on a step by step basis and, in the event that there is a problem which cannot be solved by the liquidator and counsel to the parties, they may then apply to the undersigned for a hearing to settle any such problem.


Finally the Court counts on the collaboration of all the parties and requests their respective counsel to be positively constructive in the settlement of these files.
