BANKRUPTCY ORDER (Sections 43 and 44 of the *Act*)

 - they become due.
- 1. THE COURT HEREBY ORDERS that the manner and time for the service of the within motion and application for bankruptcy order be and is hereby validated and/or abridged and that proceedings are properly returnable today and that service on any interested parties other than those parties served is hereby dispensed with;
- 2. THE COURT HEREBY ORDERS that 1817870 Ontario Inc., of the City of Paris, in the province of Ontario, be adjudged bankruptcy by virtue of a bankruptcy order hereby made on this date.
- 3. THE COURT DECLARES that for the purposes of s.2 of the Bankruptcy and Insolvency Act, R.S.C. 1985 c. B-3, the "date of the initial bankruptcy event" is July 11, 2014.
- 4. THE COURT FURTHER ORDERS that Richter Advisory Group Inc., of the City of Toronto, in the Province of Ontario, be appointed as trustee ("Trustee") of the estate of the bankrupt.
- 5. THE COURT FURTHER ORDERS that the costs of the Applicant Creditor be paid out of the estate of the bankrupt on taxation of the estate.
