• Any Ordinary Creditor may choose to have its dividends paid over time. These Creditors will share in four dividend payments in September 2008, January 2009, January 2010 and February 2011 and may participate in any Additional Dividend, if applicable.

Failure to submit the "Selection of Dividend Participation" form shall result in the Creditor being treated as a Creditor having chosen the Option B (non-electing).
