- 2. On November 10, 2010, Richter, in its quality as Receiver of Patella, caused Patella to file an assignment in Bankruptcy under section 49 of the Bankruptcy and Insolvency Act ("BIA") and Richter was duly appointed Trustee of the Bankrupt.
- 3. On November 12, 2010, the Receiver sent its Statement in accordance with s. 246(1) of the BIA and on May 24, 2011, November 22, 2011, May 28, 2012, and December 3, 2012, the Receiver filed its Interim Reports in accordance with s. 246(2) of the BIA.
- 4. The realization of assets is completed and failed to repay in full the secured creditors, HSBC Bank Canada and GE Capital.
- 5. The Receiver's Final Statement of Receipts and Disbursements dated July 4, 2013 is attached hereto.

Note 1: On November 3, 2010, pursuant to a motion filed by HSBC Bank Canada ("HSBC"), the primary secured lender, the Quebec Superior Court appointed Richter Advisory Group Inc. (formerly doing business under the name RSM Richter Inc.) ("Richter") Receiver to the assets of Patella Manufacturing Inc. ("Patella"), which shares are owned 100% by 3476600 Canada Inc.

Subsequently, on November 10, 2010, Richter, in its quality as Receiver of Patella, caused Patella to file an assignment in Bankruptcy under Section 49 of the *Bankruptcy and Insolvency Act ("BIA")* and Richter was duly appointed Trustee of the Bankrupt.

Note 2: On December 15, 2010, HSBC filed a Motion Seeking the Authorization to Sell Property of the Debtor and the Issuance of a Vesting Order, in accordance with Section 243 of the *BIA*.

On December 16, 2010 a Court Order was granted authorizing the Receiver to sell the assets of the Debtor to Maynards Industries Inc.

- Note 3: In order to obtain value for the US intercompany accounts receivable, the Receiver has entered into various settlements agreements with representatives of the Patella US subsidiaries.
- Note 4: Secured claim under Section 81.4 of the BIA pursuant to the Wage Earner Protection Program Act.
- Note 5: Distribution to HSBC in partial satisfaction of its secured advances to the Company.
