Note 1: On December 17, 2012, Probex Building Supplies Inc. ("Probex") filed a Notice of intention to make a Proposal ("NOI") in accordance with the Bankruptcy and Insolvency Act of Canada ("BIA") and Richter Advisory Group Inc. ("Richter") was named as Trustee to the NOL On January 14, 2013, Probex made a motion to the Court for an extension of the delay to file a Proposal.

On January 16, 2013, the Court granted the Company with the requested delay to file a Proposal, namely to March 1, 2013.

Following the granting of the extension, it became apparent to Probex that it would not be able to make a viable Proposal to its creditors and consequently, on January 51, 2013, the Company made a Voluntary Assignment in Bankruptoy under a, 49 of the BIA. On the same day, Richter was appointed as Trustee to the Bankrupt Estate of Probess.

Note 2: On April 2, 2013, the Canadian Imperial Bank of Commerce filed with the Quebec Superior Court a Motion for the Appointment of Richter as Receiver to the assets Probas for the Authorization of a Sale of cartain of the Company's Assets and for a Vesting Order.

Note 3: In the case the Trustee collects further amounts they will be applied against any balance due on the Trustee's fees and disbursements.
