Proc. D.E. # 61], and having briefed certain issue pursuant to the Third Amended JPO, a hearing having been held on June 25, 2015 (the "<u>Hearing</u>"), and the Court having heard the arguments of counsel at the Hearing, it is hereby

ORDERED, **ADJUDGED**, and **DECREED** as follows:

- 1. Service of the Motion, as described therein, constitutes adequate service and notice of the Motion upon all parties in interest.
- 2. The Motion is hereby GRANTED, as follows:
- 3. For the reasons set forth on the record at the Hearing, the Court determines as a matter of law and fact that the Ruling¹ is binding on the Trustee and Wheeling for purposes of the Cash Collateral Motion and the Surcharge Motion.
- Accordingly, and consistent with the stipulations entered into by the parties in the Third Amended JPO, Wheeling shall be deemed to have an allowed superpriority, administrative expense claim against the estate in this Chapter 11 case, pursuant

- A continued status conference on the Surcharge Motion shall be held on September 22, 2015 at 10:30am.
