For the avoidance of doubt, this Order approves, in the aggregate and on a final basis, in accordance with the applicable sections of the Bankruptcy Code, the Federal Rules of Bankruptcy Procedure, and this Court's local rules, \$1,514,007.78 in fees and expenses for DSI in its capacity as financial advisor to the Trustee during the Debtor's chapter 11 case, comprising (a) \$1,396,450.50 in fees and (b) \$117,557.28 in expenses.
