- Pursuant to an Order rendered on February 26, 2015 by Maître Chantal Flamand of the Québec Superior Court (Commercial Division) (the "Order"), Richter Advisory Group Inc. ("Richter") was appointed to act as receiver (the "Receiver") for the Assets Purchased from Romatec Inc. ("Debtor") until one of the following events occurs: (i) the sale of all the Assets Purchased; or (ii) any order of the Court ending the mandate of the Receiver.
- In its capacity as Receiver to the assets of Romatec Inc., Richter hereby reports the following. 2.

On February 26, 2015, Richter became the receiver in respect of the property of Romatec Inc. described below:
