However, if the Debtor advises the Trustee before the March 31, 2009 meeting that the funds necessary to satisfy the Proposal will be available, the Trustee intends to vote any proxies it receives in favour of the Proposal and to take into account the voting letters received prior to the February 26, 2009 meeting; otherwise, the Trustee intends to vote its proxies against the Proposal.
