### **Quorum:**

Pursuant to subsection 106(1), a quorum is present, and the meeting is duly called and properly constituted.

Chairperson calls meeting to order.

### Official Receiver's Report

Pursuant to Section 161 of the BIA, Mr. Mardinger, was examined by the Official Receiver on March 5, 2014. This is Mr. Mardinger's second bankruptcy. The bankrupt admitted to using his credit cards to pay for his family's lifestyle; to pay for the education of his children and for trips (partly business related) all over the world. The bankrupt liquidated assets as identified in his Statement of Affairs in order to provide funds to help sustain the operations of L'École de langues de l'Estrie. The Official Receiver has asked the trustee to verify and investigate the transactions and take appropriate actions if necessary.





### **Question period:**

The creditor asks Mr. Mardinger about his first bankruptcy, the liquidation of his personal assets and his vehicles.

The creditor also asks Mr. Mardinger how he currently affords the expenses listed on his budget given that he states having no income at present. Mr. Mardinger indicates that he has not been able to pay all his living expenses and that he and his wife are looking at selling their home and reducing their expenses. Mr. Mardinger's wife has been paying some of the household's expenses with a small amount in personal savings. The creditor ask Mr. Mardinger how he intends to pay his monthly expenses going forward; Mr. Mardinger responded that he and his wife would look for new employment and talks about possible opportunities in Vietnam or Columbia.

The creditor asks Mr. Mardinger what were his earnings in 2013. Mr. Mardinger responded that he made \$120,000 out of commissions. He also sold \$350,000 in shares and cashed in some RRSPs, sums which he re-invested in Ecole de Langues de l'Estrie. He estimates that his taxable income for 2013 totals \$600,000.

The creditor asks Mr. Mardinger if he knows of the company 2402065 Ontario Inc. Mr. Mardinger responds that he does and that the corporation was created at the suggestion of Mr. Phil Reimer.

### Affirmation of appointment or substitution of Trustee
